What is an ISO certification?

1 Manual

Implementation

3 Certification

An auditor must now visit your organisation to check that the documented processes are being followed and that the necessary changes have been made. Once they are satisfied, you will be awarded your certification.



Once you have achieved certification, the certification cycle will commence. This is made up of surveillance and re-certification audits, one of which must take place each year.


